MANAGEMENT TEAM COMMENT

After 2 months of gains, the equity markets closed down -4.18% for the STOXX 600 in Europe, -5.75% for the S&P 500 in the United States and even -7.7% for the Nasdaq.

The markets were penalised by Donald Trump's numerous announcements regarding the introduction of tariffs as from 2 April, fuelling concerns about an intensification of the trade war. These tariffs already hit Canadian steel and aluminium at 25%, Chinese products at 20% and European wines and champagnes at potentially 200%! This instability is weighing on investor sentiment and US consumer confidence, especially as Elon Musk's DOGE is launching waves of layoffs at federal agencies. At the same time, geopolitical uncertainty linked to the war in Ukraine and difficulties in reaching an agreement contributed to investors' caution. Economists are therefore revising the US growth outlook downwards.


On the positive side, the German parliament passed a major reform, ending the strict debt and deficit limitation policy. This reform frees up the defence budget from the usual budgetary restrictions and establishes a special fund of ε 500bn over 12 years for infrastructure, with the aim of reviving a struggling economy. Lastly, Chinese data surprised to the upside with industrial production and retail sales boosted by the government stimulus.

Against this backdrop, the fund ended the month down -6.19%. None of our holdings contributed positively to the fund. Our exposure to the US markets contributed nearly half of the decline, while it only accounts for 28% of assets. We took advantage of the sharp correction in the Nasdaq to add to this position. At the European level, we sold our exposure to the Swiss and UK markets to return to the eurozone, which should benefit more from the German plan. In the same vein, we initiated a line in the Max, which should benefit the most from these investments.


